The Board of Governors is pleased to present a quarterly publication that meets our commitment to communicate with you. We will highlight the newest members of our association, detail our efforts for ongoing projects, inform you about upcoming events, and importantly, provide a forum for discussion of important issues facing our association.

We have a number of improvements planned. Our most recent effort resulted in a change to our notice requirements. In October 2017, we conducted our first Referendum and presented to you two questions – first, whether we should modify the rules of conduct for meetings, and second, whether we should implement email notification. The majority of our membership answered, Yes to both questions. Upon our petition, the Supreme Court of Guam adopted and modified our Rules and By-laws, accordingly.

Great news for those of you who have been wanting more reliable internet service in the Judicial Building Center. Effective April 2, 2018, the GBA will have a dedicated password-secured wifi network. You will need to search and select the GBA\_Member network, and enter the password that you can find by reading this newsletter.

One of our priorities is to establish a permanent home for the GBA and hire an Executive Director. Outreach programs to establish a Pro Bono Clinic and A Law Series for the Manamko, are but a few of the projects intended to serve our island population. Involvement in our community projects and our social events are essential keys to fostering our relationships. 
