WHEREAS, on May 24, 2023, Typhoon Mawar passed over Guam as a category 4 typhoon, which brought significant destruction to Guam, including disruption of power and water services, structural damage to homes and businesses, and disruption of communication services; and

WHEREAS, on May 26, 2023, *I Maga'hågan Guåhan* placed Guam back into Condition of Readiness (COR) 4, although Guam remains under a declaration of a state of emergency as declared by *I Maga'hågan Guåhan* in Executive Order No. 23-002; and

WHEREAS, while power and water services have been restored to all Judiciary of Guam facilities, the Judiciary recognizes that many island residents are still without these services; and NOW, THEREFORE, because *I Maga'hågan Guåhan* has placed Guam back into COR 4, the Supreme Court, under its jurisdiction to issue orders in aid of its supervisory jurisdiction over the Superior Court of Guam and all other courts of the judicial branch of Guam, ORDERS:

The following matters shall continue to be scheduled and heard in keeping with the urgency of those matters and consistent with statutory requirements, either in person or remotely pursuant to the Judiciary's rules on video conferencing or telephonic appearance, with the court to notify all participants necessary to the proceeding:

- 1. Magistrate proceedings;
- 2. Arraignments for in-custody defendants;
- 3. Writs of habeas corpus;
- 4. Jury selections in asserted criminal matters;
- 5. Grand jury proceedings and preliminary hearings;
- 6. Preliminary hearings for detained juveniles;
- 7. Civil protection orders;
- 8. Temporary restraining orders;
- 9. Search warrants;
- 10. Warrant returns;
- 11. Emergency guardianships;
- 12. Any other locally or federally mandated hearings; and
- 13. Any other hearings at the judicial officer's discretion.

All other Supreme Court and Superior Court matters scheduled to be heard during the week of May 30, 2023, through June 2, 2023, will be rescheduled. The court will issue notices of rescheduling. Parties should contact their lawyers about their rescheduled hearing dates. These include, but are not limited to, criminal and civil trials, appellate arguments, motion hearings, probate proceedings, and child support hearings.

Further, any temporary restraining order, injunction, civil protection order, or stay set to expire on or after May 22, 2023, in any criminal or civil matter shall automatically be extended under the same terms for ten (10) calendar days from the date of this order, unless the Presiding
