Each Judge is responsible for finding another Judge to cover his/her *Ex Parte* assignment if the *Ex Parte* Judge is sick or on leave status, and must also inform the Presiding Judge who will cover his/her *Ex Parte* assignment. The Judge assigned to the case shall be appointed *Ex Parte* for his or her assigned case and shall hear any *Ex Parte* application relating to that case, including any bail hearings and arraignment warrants.
